M.Sc. Forestry Admission Notification – 2024

Applications are invited for admission into 24 seats of the M.Sc. Forestry Two-year post-graduate degree programme (of four semesters) for the academic year 2024-25:

Mode of Admissions and Eligibility Criteria:

- (i) The B.Sc.(Hons.) Forestry candidates with a minimum OGPA of 7.0 out of 10.0 are eligible to apply. However, for SC/ST candidates, the minimum OGPA required is 6.5 out of 10.0.
- (ii) The candidates should have qualified in the ICAR-AIEEA-PG entrance examination 2024.
- (iii) Weightage shall be 50:50 for performance in the ICAR-AIEEA-PG entrance examination and academic record at Under Graduate level.
- (iv) In case of tie, to break the tie, the marks in ICAR-AIEEA-PG entrance, the academic record at UG level and date birth will be considered in sequence.
- (v) The statutory reservations will be followed as per the guidelines issued by the Government of Telangana.
- (vi) There will be common courses in first semester and based on the GPA secured in first semester, the discipline will be allocated in different specialisations for 24 seats.

Procedure for Applying:

- Prescribed application form which is available at the college website <https://www.fcridhyd.in/> shall be submitted at the college or sent through the E-Mail: tsfcrid2021@gmail.com; fcridadmissions@gmail.com from 02-10-2024 to 17.10.2024.
- **Application fee to be paid online:** Rs. 1000/- for SC / ST / PH candidates and Rs. 2000/- for others should be paid on or before 17-10-2024.

General:

- i. Students who join M.Sc. Forestry are not allowed to pursue any other degree/ diploma concurrently.
- ii. The admission into M.Sc. Forestry is provisional and liable for cancellation subsequently if found repugnant to rule/ regulations or invalid by reason of incorrect/ false information furnished at the time of admission. Besides action will be taken under relevant Act/ Rules/ Guidelines.
- iii. Hostel accommodation is provided subject to availability and based on the merit of student.
