- 1. Secondary School Certificate (SSC)/ 10^{th} Standard certificate as a proof of Date of Birth or any other proof of date of Birth issued by competent authority.
- 2. Marks memo of 10+2/Intermediate or equivalent recognized by the Board of Intermediate Education Telangana State.
- 3. Proof of Local/Non-Local status of the candidates A candidate shall be regarded as a local candidate in relation to a local area (Telangana);
 - a. If he/she has studied in an educational institution or educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or first appeared in the relevant qualifying examination as the case may be and need to submit the bonafide certificates from the colleges/ schools where they have studied.
 - b. Students who have studied four consecutive years preceding the qualifying examination in more than one local area, the candidates must submit the bonafide certificate(s) of at least seven consecutive academic years ending with the first appearance in the qualifying examination as regular students.
 - c. OR Where, during the whole or any part of the four consecutive academic years in which he/she appeared, or first appeared in the relevant qualifying examination, he/she has not studied in any educational institutions during part 4/7 years, if he/she resided in that local area for a period of not less than four years immediately preceding the date commencement of the relevant qualifying examination in which he/she appeared, or first appeared, as the case may be and they have to submit a certificate to that effect from the concerned Mandal Revenue Officer /Tahasildar.
- 4. Community Certificate for SC, ST and BC candidates as per G.O. Ms.No. 58, Social Welfare (J) Dept,dated12.5.1997 issued by MRO/Thasildar, if applicable.
- 5. Economically Weaker Section (EWS) Certificate, issued by MRO/Thasildar, if applicable.
- 6. ICAR-AIEEA(P.G) 2024 Rank Card and Score Card.
- 7. B.Sc.(Hons.) Forestry Degree Certificate/Provisional Certificate and Consolidated Marks Memo.
- 8. FCRI Application Form applied.
