### **1. Eligibility:**

- Candidates should have passed Intermediate Examination (10+2 pattern) or any examination recognized as equivalent thereto by the Board of Intermediate Examination, Telangana State with the following subjects: (a) Biology (b) Physics (c) Chemistry Or (a) Mathematics (b) Biology (c) Physics (d) Chemistry or (a) Mathematics (b) Physics (c) Chemistry

**Note:** Irrespective of the subjects taken at the qualifying examination, candidate seeking admission to the B.Sc. (Hons.) Forestry course should have appeared and qualified in TG EAPCET-2025.

### **2. Criteria for selection:**

- The selection of candidates for all the seats shall be made on the basis of ranks obtained by the candidates in the Telangana State **EAPCET-2025 under the Agriculture and Engineering streams** conducted by the **Telangana State Council of Higher Education (TGCHC)**.
- In case of a tie in ranks obtained by two or more candidates in the Telangana EAPCET-2025, the marks in the optional subjects of the qualifying examination (Intermediate or its equivalent) shall be taken in to consideration. In case of a further tie, the age of the candidate shall be taken into consideration and the older candidate shall be given preference.

### **3. Age:**

- The candidates for admission into B.Sc. (Hons.) Forestry course shall be required to have completed 17 years of age with an upper age limit of 22 years for all the candidates, 25 years in respect of SC and ST candidates; and 27 years for Physically Challenged candidates as on 31st December of the year of admission.

### **4. Reservation of seats for various streams**

- 25% of the regular seats to MPC/MBiPC stream students who have qualified in the Telangana State Engineering Agriculture and Medicine Common Entrance Test (TGEAPCET 2025).
- The remaining 75% of seats will be allocated to Bi.P.C stream students based on their TGEAPCET 2025 scores.
- Following two rounds of seat allotment for MPC stream, vacant seats if any, shall be converted to BiPC stream students

### **5. Reservation Policy for Admission**

The admission will be purely based on merit and the reservation roster of the State Government of Telangana in vogue.

As per the statutory provisions followed in the state of Telangana

- a. General Category: 46% seats are reserved for General category.
- b. Backward Classes: 29% of seats are reserved under this category.  
(BC-A – 7%; BC-B – 10%; BC-C – 1%; BC-D – 7%; BC-E – 4%)
- c. Scheduled Caste (SC): 15% (SC Group-I:1%, SC Group-II:9%, SC Group-III:5%) & Scheduled Tribe (ST): 10%
- d. EWS: 10% (Supernumerary)
- e. Reservation of seats for Women: In the course, 33.3% of the seats shall be reserved in favor of women candidates from each category (Horizontal).

**Other Reservations:**

- a. Children of Armed Forces Personnel (CAP) - 2%
- b. National Cadet Corps. (NCC) - 1%
- c. Games & Sports - (0.5%)
- d. Physically Challenged - 5%.

**6. Allocation of Seats:**

- Of the total seats, 85% of the seats are reserved for local candidates, and 15% of seats are unreserved.

**In this regard, as per the G.O. Ms. No. 15 of the Higher Education (TE) Department, Dated: 27-02-2025, the reservation of seats is as follows:**

Admission to 85% of the seats shall be reserved in each course in the Educational Institutions in the State for local candidates of OU area as specified in the Andhra Pradesh Educational Institutions (Regulations and Admissions) Order, 1974 as subsequently amended and the remaining 15% of the seats shall be unreserved seats to the following:

- a. All the candidates are eligible to be declared as local candidates of the O.U. area.
- b. Candidates who have resided in the State for a total period of ten years, excluding periods of study outside the State, or either of whose parents has resided in the State for a total period of ten years, excluding periods of employment outside the State;
- c. Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporations, Local Bodies, Universities, and other similar quasi-public institutions within the State; and
- d. Candidates who are spouses of those in the employment of the State or Central Government, Public Sector Corporations, Local Bodies, Universities and educational institutions recognized by the Government or a University or other competent authority, and similar other quasi-Government institutions within the State.

**Note:** The guidelines issued by the Government of Telangana from time to time shall be followed scrupulously, including the reservations for 15% of seats under the Unreserved quota.

**7. Residential Certificate:**

- Applicants who have a gap/break in the years of study for reasons other than failure or those who passed the qualifying examination by private study have to submit this certificate issued by the Tahsildar. In case, the applicant has resided in more than one place, separate certificate from the Tahsildar, should be furnished for such places of residence.

**8. Hostel facility:**

- Compulsory residential program and rooms shall be provided subject to the availability of accommodation.

**9. Dress code:**

- Light blue shirt and Dark Blue trouser for boys and Light blue Kameez and Darkblue salwar & Blazer / Waistcoat for girls.

**10. Original certificates to be produced at the time of counseling:**

- Secondary School Certificate (S.S.C.) / 10<sup>th</sup> standard. Certificate as a proof of Date of Birth.
- Pass Certificate cum Memorandum of Marks obtained by the applicant in the qualifying examination (Intermediate (10+2) or its Equivalent Examination).
- TS EAPCET – 2025 Rank Card and Hall Ticket.
- Bonafide/ Study Certificate(s) from 1<sup>st</sup> to 12<sup>th</sup> Class
- Transfer Certificate of the institute last studied.
- Residence Certificate of Telangana.
- The certified copy of the Social Status Certificate issued by the competent authority of Telangana in case of applicants belonging to Backward Classes, Scheduled caste, and Scheduled Tribes.
- The latest certified copy of the EWS Certificate valid for the year 2025-26 issued by the competent authority in case of applicants belonging to the EWS category
- The certified copy of the Physically Challenged Certificate, if applicable.
- Children of Armed Personnel Certificate/Defense Personnel Certificate, if applicable.
- National Cadet Corps (NCC) Certificate, if applicable.
- Sports and Games Certificates along with Form I, II, III & IV(Whichever is applicable),which are mandatory of claiming a seat under the Sports quota, if applicable.
- F.C.R.I. Registration Form applied online.

**11. Fees:**

- The particulars of fees are given here under. The candidates who are granted admission have to pay the prescribed fees immediately at the time of admission.

**Note:** 1. In case of partial fee payment / non-payment of fee (for both regular and payment), the Candidate shall have no right to ask for seat and it shall be allotted to the next candidate in merit.

2. No refund is applicable in case of students cancelling admissions after the admission process is completed, as the seat cannot be filled up further.
