**Instructions to Candidates for Attending Certificate Verification for Admission into
B.Sc. (Hons.) Forestry – 2026**

Certificate verification for admission into B.Sc. (Hons.) Forestry – 2026 will be conducted between 11:00 AM and 04:30 PM on 24.08.2026 & 25.08.2026 at Forest College and Research Institute (FCRI), Hyderabad @ Mulugu, Siddipet District.

Candidates attending certificate verification are required to bring the following original certificates/documents:

1. **Secondary School Certificate (SSC)/10th Standard Certificate** as proof of Date of Birth, or any other valid proof of Date of Birth issued by the competent authority.
2. **Marks Memo of 10+2/Intermediate or equivalent qualification** recognized by the Board of Intermediate Education, Telangana State.
3. **Reservation Certificate/Documents:** Reservation shall be followed as per the Rules and Regulations, Guidelines, and Circulars issued by the Government of Telangana from time to time.

1. Proof of Local/ Non-Local status of the Candidates –

a. A candidate shall be regarded as a local candidate in relation to a local area (Telangana) for admission into 85% seats under local category;

- i. If he/she has studied in an educational institution or educational institutions in OU area (Telangana) for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or first appeared in the relevant qualifying examination as the case may be and need to submit the bonafied certificates from the colleges/ schools where they have studied.
- ii. Students who have studied four consecutive years preceding the qualifying examination in OU area (Telangana), the candidates must submit the bonafide certificate(s) of at least seven consecutive academic years ending with the first appearance in the qualifying examination as regular students.
- iii. OR Where, during the whole or any part of the four consecutive academic years in which he/she appeared, or first appeared in the relevant qualifying examination, he/she has not studied in any

educational institutions during part 4/7 years, if he/she resided in Telangana for a period of not less than four years immediately preceding the date commencement of the relevant qualifying examination in which he/she appeared, or first appeared, as the case may be and they have to submit a certificate to that effect from the concerned Mandal Revenue Officer /Tahsildar.

b. For admission into 15% seats under unreserved category:

- i. All the candidates are eligible to be declared as local candidates of the OU area.
 - ii. **Residence Certificate (for candidate or either parent) for a period of 10 years issued through Mee Seva/ by the Tahsildar/ MRO:** for Candidates who have resided in the State for a total period of ten years, excluding periods of study outside the State, or either of whose parents has resided in the State for a total period of ten years, excluding periods of employment outside the State;
 - iii. **Employer Certificate, ID proof of parent:** for Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporations, Local Bodies, Universities, and other similar quasi-public institutions within the State; and
 - iv. **Employer Certificate/ Marriage Certificate or relevant legal proof of relationship:** for Candidates who are spouses of those in the employment of the State or Central Government, Public Sector Corporations, Local Bodies, Universities and educational institutions recognized by the Government or a University or other competent authority, and similar other quasi-Government institutions within the State.
4. **Community Certificate** for SC, ST and BC candidates issued by the **MRO/Tahsildar** as per G.O. Ms. No. 58, Social Welfare (J) Department, dated 12.05.1997 and amendments issued therein, wherever applicable. Non-local candidates belonging to the BC category shall submit an OBC Certificate issued by the competent authority.
 5. **Economically Weaker Section (EWS) Certificate**, issued by the MRO/Tahsildar, if applicable.
 6. **National Cadet Corps (NCC) Certificate** issued by the competent authority, if applicable.
 7. **Sports Certificate** in Form I to IV issued by the competent authority, if applicable.

Note: Seats under **either the NCC category or the Sports category** will be allotted as determined at the discretion of the competent authority.
 8. **Children of Armed Persons (CAP) Certificate** issued by the competent authority, if applicable.

9. **Persons with Disabilities (PwD) / Physically Handicapped Certificate** issued by the competent authority, if applicable.
10. **TGEAPCET–2026 Rank Card and Hall Ticket.**
11. **FCRI B.Sc. (Hons.) Forestry – 2026 Application Form** submitted online.
12. **The dates for certificate verification of candidates under the Payment Quota will be announced shortly.**

Important Note :

- Attending certificate verification does not guarantee admission.
- Candidates shall bring all original certificates/documents for verification.
- Two sets of photocopies of all the above certificates/documents shall be submitted at FCRI during certificate verification.
- Candidates are advised to report within the prescribed certificate verification time and bring all applicable documents to avoid inconvenience.
