Instructions to candidates for attending certificate verification for
Admission into B.Sc. (Hons.)Forestry-2025

Certificate verification will be done between **11.00AM to 04.30 PM of 01.08.2025** at Forest College and Research Institute, Hyderabad at Mulugu, Siddipet District.

The following original certificates should be brought by the candidates:

1. Secondary School Certificate (SSC)/10th Standard certificate as a proof of Date of Birth or any other proof of date of Birth issued by competent authority.
2. Marks memo of 10+2/Intermediate or equivalent recognized by the Board of Intermediate Education Telangana State.
3. Reservation will be followed as per the Rules and Regulations and the Guidelines, Circulars issued therein issued by the Government.
4. **Proof of Local/ Non-Local status of the Candidates –**

a. A candidate shall be regarded as a local candidate in relation to a local area (Telangana) for admission into 85% seats under local category;

- i. If he/she has studied in an educational institution or educational institutions in OU area (Telangana) for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or first appeared in the relevant qualifying examination as the case may be and need to submit the bonafied certificates from the colleges/ schools where they have studied.
- ii. Students who have studied four consecutive years preceding the qualifying examination in OU area (Telangana), the candidates must submit the bonafide certificate(s) of at least seven consecutive academic years ending with the first appearance in the qualifying examination as regular students.
- iii. OR Where, during the whole or any part of the four consecutive academic years in which he/she appeared, or first appeared in the relevant qualifying examination, he/she has not studied in any educational institutions during part 4/7 years, if he/she resided in Telangana for a period of not less than four years immediately preceding the date commencement of the relevant qualifying examination in which he/she appeared, or first appeared, as the case may be and they have to submit a certificate to that effect from the concerned Mandal Revenue Officer /Tahasildar.

b. For admission into 15% seats under unreserved category:

- i. All the candidates are eligible to be declared as local candidates of the OU area.
- ii. **Residence Certificate (for candidate or either parent) for a period of 10 years issued through Mee Seva/ by the Tahsildar/ MRO:** for Candidates who

have resided in the State for a total period of ten years, excluding periods of study outside the State, or either of whose parents has resided in the State for a total period of ten years, excluding periods of employment outside the State;

- iii. **Employer Certificate, ID proof of parent:** for Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporations, Local Bodies, Universities, and other similar quasi-public institutions within the State; and
 - iv. **Employer Certificate/ Marriage Certificate or relevant legal proof of relationship:** for Candidates who are spouses of those in the employment of the State or Central Government, Public Sector Corporations, Local Bodies, Universities and educational institutions recognized by the Government or a University or other competent authority, and similar other quasi-Government institutions within the State.
5. **Community Certificate** for SC, ST and BC candidates issued by MRO/ Thasildar as per G.O. Ms. No. 58, Social Welfare (J) Dept, dated 12.5.1997 and amendments issued therein, if applicable. The non-local candidates belonging to BC category shall submit OBC certificate issued by the competent authority.
 6. Economically Weaker Section (EWS) Certificate, issued by MRO/Thasildar, if applicable.
 7. National Cadet Corps (NCC) Certificate issued by competent authority, if applicable.
 8. Children's of Armed Persons (CAP) certificate issued by competent authority, if applicable.
 9. Physically Handicapped Certificate issued by competent authority, if applicable.
 10. TGEAPCET–2025 Rank Card and Hall Ticket.
 11. FCRI Application Form applied online.
